2. Recap briefly what outcomes the project was designed to achieve.

The project is designed to achieve the following objectives:

- Outcome 1: Single mothers (SMs) develop knowledge, skills, and resources that directly lead to sustainable income and successful household management.
- Outcome 2: Family incomes are sufficient to cover expenses and enable savings.
- Outcome 3: Safety and hygiene in the living environment are ensured.
- Outcome 4: SMs' children have expanded and brighter future opportunities through education.
- Outcome 5: Single mothers gain access to government support policies.



The single mother is delighted to join the project and receive funding support for chicken farming.

3. What was accomplished in connection with this project? Please address each stated objective. If any project objectives were changed, please also explain the circumstances

changed, please also explain the circumstances leading to the modification of the objective(s).

During the implementation of the Empowering Foundations for Women and their Children (EFWC) program from April 2024 to January 2025, COV consistently adhered to the objectives and expected outcomes outlined in the project's initial design. At the same time, COV has made continuous efforts to enhance the quality and depth of each activity to achieve the desired results and deliver

meaningful, sustainable benefits to single mothers and their children. Below is a detailed description of the project's achievements during this period:

Livelihood: Economic stability plays a critical role in ensuring the well-being and quality of life for impoverished families, especially for single mothers. To enhance self-reliance and improve incomes, the EFWC program has implemented livelihood development support for 60 single mothers through diverse livelihood models tailored to their skills and circumstances. Specifically:

- 49 households engaged in small businesses offering a wide range of products and services, such as sugarcane juice, fish, fish cakes, scrap trading, noodles, bread, tapioca cakes, groceries, refreshments, snacks, fruits, flowers, vegetables at markets, online sales, and specialty products from Binh Dinh Province. These trades were selected based on local market demand and the practical capabilities of the participants.
- 04 households received support for transportation means to facilitate their work and trade, including housekeeping services, transporting goods, and delivering vegetables to local markets.
- 03 households pursued garment-related work, such as tailoring, selling, and repairing clothes to meet the growing needs of customers in their area.
- 02 households opened hair and nail salons, providing beauty services for women in the community and establishing a steady source of income. 01 household engaged in chicken farming, contributing fresh poultry products while improving their livelihoods through smallscale livestock farming.
- 01 household opted for home-based childcare services, addressing the rising demand for childcare in the local community.

The program not only provided capital, tools, and essential training but also offered continuous monitoring and counseling to ensure that these livelihood models were implemented effectively and sustainably. These efforts have significantly contributed to helping single mothers overcome economic challenges, stabilize their lives, and build a brighter future.

Housing: One of the significant challenges women face in the EFWC program is the poor housing conditions and the lack of essential furniture. Many homes are in disrepair, with insufficient or wornout items that fail to meet the basic needs of daily living. During this reporting period, the program

implemented several initiatives to improve household living conditions to address this issue. These efforts aimed to provide practical support and enhance the quality of life for the participants and their families. Specifically:

- Consultations were conducted to assess individual household needs and prioritize necessary support.
- Essential household items were provided to improve comfort and functionality, including 02 fans to improve ventilation and address the hot climate, 07 beds (queen sizes and twin sizes) to replace damaged or missing furniture and ensure better sleep quality, 10 mattresses (queen sizes and twin sizes) for increased comfort and hygiene, 17 wardrobes for storing personal belongings and improving living space tidiness.

These efforts contribute to creating a safer and more stable home environment for women and their families. By providing durable and practical household items, the program helps reduce daily stress and creates conditions that enable participants to focus on improving their livelihoods and overall well-being. In addition, the program continues to work closely with participants to identify further housing improvement opportunities, fostering long-term sustainability and better living standards for the women and their children.

Education: To enhance educational opportunities and improve study conditions, the program has implemented various initiatives, focusing on providing essential tools and financial support for students. During this reporting period:

- Basic study tools were provided to improve the learning environment at home, including 18 sets of study tables and chairs to create proper study spaces for students, 60 study lamps to ensure adequate lighting for evening study sessions, 12 bicycles to facilitate access to schools, especially for children in rural areas or those who must travel long distances.
- Scholarships were granted at the start of the 2024–2025 school year to help families cover educational expenses, such as uniforms, textbooks, and other school supplies. A total of 60 students received scholarships, which significantly alleviated the financial burden on their single mothers.

These efforts empower single mothers by easing their financial pressure and fostering an environment that values and supports learning. Additionally, one child of a single mother is currently receiving support through COV's Bright Scholars Program to continue their university education.

Capacity Building and events:

- All 60 women took part in livelihood training sessions designed to equip them with skills in capital management to effectively and sustainably run their small businesses.
- 10 women and their children attended a career orientation event focused on the restaurant, hospitality, and culinary fields. 2 of them decided to pursue professional culinary training programs and are currently enrolled in structured courses, opening opportunities for stable employment.
- Experienced experts conducted training sessions tailored to the specific needs of single mothers. 57 women participated in a workshop titled "Recognizing and Preventing Online Scams and Protecting Children in the Digital Environment." The post-training survey showed that 44.4% of women reported feeling very confident in identifying signs of high-tech fraud, and 55.6% indicated they felt more confident than before, having gained valuable knowledge about recognizing such risks.

- To ensure a meaningful celebration for the upcoming Lunar New Year (Tet), single mothers received Tet gifts for 2025. This initiative provided material support and emotional encouragement, helping the women and their families feel cared for and connected during Vietnam's traditional holiday.

There is no change in the number of beneficiaries.

5. What challenges did you face in connection with this project? How did you address these challenges?

COV has faced several challenges in supporting single mothers through the livelihood development program. One significant incident involved a single mother who became a victim of an online scam shortly after receiving financial assistance. The scammer impersonated a government official and a representative from the social insurance agency, tricking her into transferring her entire personal savings, including the funds provided by the program. This unfortunate event placed her in a dire financial situation.

- In collaboration with the local government, local authorities quickly reported the incident, and COV decided to waive 30% of the livelihood capital recovery activities outlined in the program's plan. At the same time, both COV and local government agencies are working to secure additional support for the affected individual. Furthermore, COV and local authorities have used Zalo group chats (a widely used social media platform in Vietnam, similar to Facebook or WhatsApp) in each ward, involving women from both district and ward levels, to raise awareness and warn the community about similar scams.
- To address these concerns further, COV promptly sought experts in cybersecurity and combating online crime to organize a training session in December 2024 titled "How to Identify and Prevent Online Scams for Women and Prevent Online Abuse for Children." This initiative aims to raise awareness about protecting assets for single mothers and ensuring the safety of both themselves and their children in the context of global digital transformation.

In addition, some of the needs expressed by single-mother families and their children are not yet covered by the program's current support measures. For example, many women require financial assistance to repair homes that have fallen into disrepair or to cover additional educational expenses when their children move on to middle school. When these needs go unmet, single mothers often experience prolonged anxiety because, despite working very hard, their incomes still fall short of covering basic living costs. This situation highlights the persistent challenges they face and underscores the importance of establishing more comprehensive support measures. The plan for 2025:

- Housing Repair Support: COV intends to review and assess 13 single-mother households living in severely deteriorated housing conditions, which pose safety risks during the rainy, flood, and storm seasons. This assessment will be based on criteria that consider psychological, emotional, and physical impacts, as well as potential risks to single mothers and their children. Based on the findings, COV will carry out deeper interventions to improve living environments for these families.
- Educational Support for Children: For the 41 single-mother households with two or more children, COV will conduct a need assessment to provide additional educational support, especially for children transitioning to a new academic level. All expenses for these initiatives will be covered by any remaining or unused portion of the initial budget, made possible by cost savings achieved during the earlier procurement of supplies and equipment.
- 6. Is your organization or project situation different from what is presented in the approved proposal? For example, new executive director, significant project staffing changes or NGO affiliation, loss of large funding, or other significant changes?

COV and the project retain their original objectives with no modifications.

7. What were the most important lessons learned?

The greatest strength of the EFWC program is COV's comprehensive approach to individualized business and care plans for single mothers. After conducting a series of needs assessments and consultations, the single mothers, with the help of COV staff, develop personalized care plans to address their needs and ensure their commitment to implementing their business plans, and providing their children with a safe home, positive parenting, nutritious food and education support. This case-by-case management approach minimizes the risk of livelihood failure and helps break the cycle of poverty for these single mothers.

A highlight of the EFWC program was COV's focus on helping single mothers build social capital, which included fostering connections among single mothers and providing each other with mutual support through knowledge sharing, mutual support for business development, and exchanging experiences. The connection developed among the single mothers improved their sense of well-being, confidence, and value to each other while helping them grow their businesses and achieve sustainable livelihoods.

The EFWC program has made progress in seeing and understanding the causes of the difficulties and challenges of 60 single mothers. From here, the program determines the goal of enhancing capacity for single mothers is very important.

8. What has changed within your organization as a result of this project?

Enhancing the Effectiveness of the Monitoring and Evaluation (M&E) System: Through this project, COV has significantly improved the Monitoring and Evaluation (M&E) system. Previously, efforts

focused on tracking progress within five core areas: livelihoods, education, healthcare, living environment improvements, and event-based policies for single mothers. The refined M&E system now provides deeper insights into broader program impacts, such as the capacity-building progress of single mothers and their children, the development of social relationships, and the sustainability of single-mother households within their communities.

Enhanced Focus on Capacity Building for Single Mothers: COV has shifted focus to emphasize capacity-building initiatives for single mothers. This approach moves beyond short-term assistance by equipping women with the skills and confidence needed to become self-reliant and effectively utilize available resources. By fostering personal and professional growth, COV empowers these women to build sustainable futures for themselves and their families, breaking the cycle of poverty in the long term.

Strengthened Organizational Reputation and Expertise: Through surveys and focus groups with beneficiaries and local partners, the EFWC program has been recognized as successful, positively impacting many single mothers and their families. This recognition, outlined in the Stakeholder Insights and Strategic Recommendations Report (November 2024), further strengthens COV's reputation as an organization capable of delivering impactful programs for vulnerable groups. COV is now positioned as a trusted partner for donors, government agencies, and other organizations.

Increased Awareness and Commitment to Women's Empowerment: The project has reinforced COV's commitment to women's empowerment and underscored the importance of addressing systemic challenges faced by single mothers. This focus has shaped the design and implementation of programs, ensuring every initiative prioritizes sustainability and empowerment.

9. Describe the unexpected events and outcomes, including unexpected benefits.

One unexpected outcome of this project was the realization of the significant benefits of fostering opportunities for single mothers to support each other. For example, COV supported Ms. Do, a single mother in Khue Trung ward, to start a trading business. Through COV, she connected with Ms. Huong, a single mother from Hoa Phat ward, who had previously established a successful business selling steamed cakes and dumplings. Ms. Huong supplied Do with products and shared sales techniques and strategies, helping Do build a thriving business that now generates steady income. Their growing connection has strengthened their mutual success, demonstrating the power of collaboration within the single-mother community.

COV has also expanded collaboration by linking beneficiaries across programs. For instance, university students in Central Vietnam assist the EFWC program with monitoring and evaluation (M&E) activities, ensuring accurate assessments while gaining hands-on community development experience. Additionally, single mothers in the EFWC program have been encouraged to form support networks with caregivers from the Hope System of Care for Children with Disabilities (HSC) program. These connections enable participants to share experiences, provide emotional support, and collaborate on livelihood activities, enhancing their overall well-being.

By integrating beneficiaries across programs, COV fosters a unified support network where individuals can leverage each other's strengths. This approach amplifies program impact, nurtures a culture of collaboration, and improves the quality of life for all involved. These synergies highlight the transformative potential of community-driven solutions, ensuring no one is left behind.

10.Did you change your strategy as a result of obstacles you encountered? How will you address these challenges in the future?

COV has not changed the initial strategy outlined for supporting single mothers and their children during the project implementation. COV consistently adapts to emerging situations throughout the

project cycle, developing step-by-step support plans tailored to each specific circumstance.

With 16 years of experience running this program, COV has developed the ability to anticipate potential risks and challenges. The proposed plans are designed to be adaptable, addressing specific issues while maintaining the project's overall goals. Rather than altering the core strategy, COV focuses on refining individual activities, optimizing resources, and implementing targeted solutions to overcome obstacles and provide the best possible support for single mothers and their children.

Looking forward, COV will continue using this flexible approach, combining it with close monitoring and ongoing improvements. This ensures challenges are effectively managed, and the project delivers increasingly sustainable benefits to those we serves.
